Buehler calls for Franks and Acosta resignations

County Chair Candidate says Franks protected political ally

PRESS RELEASE

"(Board Member) Carlos Acosta needs to resign - NOW!" said Mike Buehler, Candidate for McHenry County Board Chairman. "And (County Board Chairman) Jack Franks needs to follow suit and resign as well."

Acosta was arrested Thursday, along with his former supervisor at the Illinois Department of Children and Family Services, Andrew Polovin. The charges against the pair include two counts of felony endangering the life of a child and one felony charge of reckless conduct each.

The charges are related to the widely perceived mishandling of the DCFS case that should have protected 5-year-old AJ Freund who was forced to take a cold shower as a punishment, beaten on the head until killed and then

had his body dumped by his parents on April 15, 2019.

Acosta and Polovin were initially placed on desk duty after their mishandling of the case came to light. In December, they were both fired from DCFS.

Many feel that, as an ally, Franks stood in the way of calls for Acosta's resignation.

"Just recently, Franks called Acosta a model board member," said Buehler. "Franks should have asked Acosta to resign a long time ago. But the chairman put politics ahead of justice or decency. With Franks, politics always come first."

Buehler said that Franks' approach to cases of improper behavior depend on where those involved stand politically. If it's a case related to a Franks ally, the chairman simply seeks to weather the storm. Franks is currently under investigation for sexual assault, sexual harassment and stalking a young lady while serving in Springfield as the representative of the 63rd District.

Applying the same standards as Franks, his ally, Illinois House Speaker Michael Madigan ordered an investigation into the accusations which reported that the accusations were "credible."

Ives calls out Casten Campaign for Vile Vandalism in 6th Congressional race

Using possibly the most vile word in the English language, in early September, a supporter of Illinois 6th District Rep. Sean Casten, a Democrat, tagged campaign signs belonging to Republican Challenger Jeanne Ives. The Ives campaign received numerous reports of vandalized yard signs in Wheaton, Naperville and Glen Ellyn. The signs were painted with a single word - C***. In each case, a police report was filed and the Ives campaign reported the attacks on social media.

In one such post, Ives wrote, "It doesn't matter that Sean Casten issued a CYA response about those vandalizing our signs with the most vile possible language. This is the kind of division and hate he has stoked from the moment he stepped foot in the political arena."

Ives said that Casten cites as his ideological North Star Dan Savage, who has said that "all Republicans should be F***ing dead."

Casten said what voters think should not matter. He has made wildly unsubstantiated charges implying that his Republican colleagues in the US House are Nazi Sympathizers.

He also mocked a Bible verse on Twitter and told a climate expert - Michael Shellenberger- who has drawn different conclusions

than Casten, that questioning him was a "waste of time."

Casten called Dan Crenshaw, a combat Veteran and Navy Seal, a racist over a policy disagreement. also referred to gun owners as people with small genitals.



Protestors block Emergency Room

Chant "We hope they die" as ambushed deputies rushed for life-saving care

An ambush in Compton, CA, Sept. 12, left two Los Angeles County Deputies, a 24-year-old male and a 31-year-old mother, in critical condition, clinging to life. Pouring salt on the wound, protestors had to be cleared from the entrance to the local hospital Emergency Room.

As the deputies were wheeled into the hospital, protestors chanted, "WE HOPE THEY DIE!" and "Death to Police!"

The deputies were ambushed in their squad car outside a Compton metra station when a lone gunman walked up to the vehicle and opened fire.

"Moments ago, 2 of our Sheriff Deputies were shot in Compton and were transported to a local hospital," the Sheriff's Department tweeted. "They are both still fighting for their lives."

ABC News has reported a 28-percent increase in the number of police shot in the line of duty in 2020 compared to 2019.

The rash of violence against police is seen as a response to claims of police violence against blacks following the death of George Floyd at the hands of four Minneapolis Police Officers on May 25.

Protests that have swept the country for going on four months have been led by Black Lives Matter and Antifa members who have called for the defunding of the police.

Though data does not support the claim that police are randomly killing black men, Democrats have only recently spoken out against the violence in the streets. Prior to that, even members of Former VP and Presidential Candidate Joe Biden were posting bail for rioters arrested for committing acts of violence.

Even local Rep. Lauren Underwood has spoken in defense of the rioters and the notion of diverting funds away from the police.

While the death of Floyd was condemned by virtually everyone, and from both sides of the political aisle, many have pointed out that the data does not support the idea that the police are randomly killing black men in the streets.

"The violence and radicalism we are seeing in our cities has gone too far," said IL Sen. Jim Oberweis, who is running against Underwood in the 14th District. "Blocking the entrance to hospitals in an effort to delay medical treatment for police officers is despicable behavior. I unequivocally condemn these actions.

We must come together as a nation but that can only happen when those who would perpetuate violence are stopped."

And, yes, we believe this is a 'newspaper' Though provided by the McHenry County Republican Party, we believe it is as much a newspaper as virtually any other print publication. Mark Curran slams Durbin

Incumbent poses a threat to liberties

IL Senate Candidate Mark Curran, a former Lake County Sheriff and Special Prosecutor with the Lake County State's Attorney's office, is calling out his opponent, incumbent Sen, Dick Durbin, as one of the "career politicians (who) are destroying the country.

He said that Durbin and other Democrats have brought America to a crossroad. That crossroad includes a process where the wealthiest Americans and richest corporations have access to Congress to the point where they can virtually write rules that benefit themselves at the expense of the middle class.

Do you trust Springfield with unlimited tax authority?

They call it 'The Fair Tax.' But is giving politicians more taxing authority really about 'fairness'? The referendum was placed on the ballot by Democrats who have sufficient power in Springfield that they didn't need help from Republicans to get it there. And there was nothing the Republicans could do to stop it.

Politicians like to put warmfuzzy names onto legislation the way ad men use words to sell products. But buyer beware.

Republicans are recommending that you vote against the proposed Constitutional Amendment that would, in the future, give the state the authority to raise income taxes without going to the voters for approval. In the last ten years, Springfield Democrats have raised income taxes on Illinois residents twice.

"Does anyone think they are better off now because they are paying higher income taxes?" asked Cal Skinner, a Republican and a staunch opponent of higher taxes who served in the IL House from 1993 to 2001. "And you may find the timing of the referendum rather peculiar."

As voters find the referendum on their ballots this fall, numerous Democrat legislators are under Federal investigation, including House Speaker Mike Madigan. He supports the amendment giving politicians greater taxing authority. But he is under investigation for taking bribes and favors from ComEd in exchange for support of rate increases and legislation favorable to the utility company.

Supporters of the proposal take the "Trust us" approach when trying to sell it to voters. They argue that only the wealthiest three percent will see their taxes increase. They say, "Trust us" not to increase tax rates on anybody else.

But the tax rates are not in the Constitutional Amendment. They are in state law and state law can be changed.

The amount of money the new tax rates bring in isn't nearly enough to bring Illinois out of the financial pit Democrats buried the state in after almost 20 years of unfettered spending.

Increased pressure to tax lower incomes is also coming from lost taxes caused by Democrat Gov. JB Pritzker's shutdown of the Illinois economy in response to the coronavirus.

The higher income taxes target entrepreneurs and job creators. Many of these people have already left the state. With the new tax, the pace of the exodus is liable to increase.

"So, if you trust Springfield politicians, by all means, Vote "Yes," said Skinner. "But if you think it's a little foolish to trust Springfield again, you might just want to vote "No."

"He is too busy trying to make America bitter. That is who he is. Is that what you want in 2020?"

In another post on social media, Ives wrote, "We are not going to hide the hate that Sean Casten stokes anymore. We issued a soft statement on the vandalism and theft we were dealing with in an August 26 post. Now we are just going to show you."

She said she prefers civility in politics. But returning civility to Casten's political attacks just doesn't work.

In her latest post of an additional vandalized sign in Wheaton, also painted with the C*** word, while addressing Casten personally, Ives said, "This report and photo was sent to our office

today and was reported to Wheaton PD.

"I have lived in Wheaton for 28 years. I have raised a family here and my daughter is still in high school here. I have served this community as a volunteer from coaching cross country to working with the St. Vincent DePaul Society.

"And I stood up for your family and to protect the lives you were trying to build (while you were in the legislature working with) politicians who view you as an ATM for all of their waste, fraud, corruption and abuse of public systems."

Ives concluded that the hate Sean Casten has stoked is out of control. And it is not representative of this community.

But instead of following through on the matter, Madigan's office buried the report and Madigan merely required Franks to have a State Police escort any time he was on State Capital property.

"This is the political two-step we see in Illinois politics," said Buehler. "Politicians do a little dance to protect each other when they get in trouble rather than putting justice and the public interests first. Enough already. It's time for these people to start doing the right thing. And the right thing for Chairman Franks is to resign, not to mention that Acos-

ta has got to go."

Recently, at a Special County Board Meeting, Board Member Chuck Wheeler called for Franks' resignation due to the allegations against the chairman.

"It's unacceptable that we allow this type of individual to roam freely in our midst," said Wheeler. "We have employees who expect security and safety in their work environment."

Franks called Buehler's call for his resignation political. But Buehler said, "Politics are what kept Jack from doing his job in the first place.





Katherine Keefe Announces Re-Election Bid

Kathy Keefe is seeking re-election to a fourth term as McHenry County Circuit Clerk. She has worked in the office for 33 years, serving the last 12 as the elected Circuit Clerk.

"During my first 3 terms, our primary focus was improving public access to court records, while also increasing use of technology to improve customer service and reduce costs," Keefe said. "We were successful in putting court records online my first year in office and gradually, by not filling vacant positions, allowed for a reduction in staff by 21 positions saving county taxpayers \$1.2 million annually in personnel costs."

The Circuit Clerk position is a constitutional office serving as the court's record keeper.

"While some wonder why a clerical office like the Circuit Clerk is an elected position, I see the biggest reason being fiscal accountability to the taxpayer," said Keefe. "Poorly run offices can cost taxpayers a lot of unnecessary dollars. Not only have we reduced personnel cost, we also have cut our printing expenses by more than 50 percent. As an elected official I take my responsibility to the taxpayer very seriously."

Under Keefe's leadership the McHenry County Circuit Clerk's office has been a leader is technology usage in the state.

"We provide text and email court-date reminders with a free program developed in-house, and an Attorney Access Portal to allow attorneys to electronically view their case files," Keefe said.

"We introduced electronic filing years before it was mandated, and with the cooperation of the 22nd Circuit's progressive judiciary were able to eliminate use of paper files in all courtrooms."

When asked why she's seeking another term, Keefe said, "While we have accomplished so much, there is still work to be done."

Some of the projects currently under development include an integrated electronic criminal complaint program and online scheduling software for attorneys. Keefe says goals during the next term will include expansion of electronic orders.

"Electronic orders are the next frontier for efficiency and cost savings in the court system," she said. "We have pilots in some courtrooms but have expansion plans for the coming months,"

She further points out that years of working in the office is one thing, but a proven track record of improved transparency, customer service and budget reductions while leading the office is another, and reason to support her over her opponent in the coming election.

Retired IDOT inspector describes County Board Chair Candidate Buehler

"Kind of guy you'd like to have a beer with."

Buehler was an emplo

You want to know what a politician is like, just ask him or her. They'll tell you the answer they want you to hear. But if you want to really get to know them, you need to ask someone else – someone who has known them long enough to give you an unbiased perspective on what makes this candidate tick.

Neil Joslun, of Lake Zurich, is a retired IDOT Senior Proportioning Inspector. He worked with IDOT for 35-and-a-half years and retired in December of 2018. During his time with IDOT, Joslun got to know McHenry County Board Chairman Candidate Mike Buehler rather well.

He's known Buehler for about 30 years. Joslun worked closely with contractors who calibrated scales. As Joslun put it, the scales are used to ensure taxpayers get what they pay for with road projects. In other words, Joslun worked with Buehler to ensure that road contractors weren't overcharging or under delivering on the material used in road projects.

Joslun said that Buehler was probably in his early 20s when they met. He described him as very enthusiastic, hardworking and gregarious. At the time, Buehler was an employee with Eadys Scale Service. But, in 1994, he and his twin brother Tim purchased the company and changed the name to D&M Scale Service Inc.

"We would do Scale Calibrations together," said Joslun. "I had to sign off on the calibrations and Mike would put his certification number (registered with the state) on the calibrations. He was diligent and concerned with maintaining his company's reputation ... fiercely quarded their reputation."

Joslun said that the Buehlers were so successful guarding their reputation that D&M was calibrating scales at about 80-percent of the plants where Joslun worked.

"Mike made sure things were done right," said Joslun. "If there was a problem, he got at it right away."

Joslun said he was impressed with the way Buehler worked with his employees. "He would trust the guys, after they were properly trained, to do their job. He didn't lord over them."

From Joslun's perspective, this resulted in a positive working environment with D&M. "It seemed most of his guys were with him quite a while ... longer than some of the other companies I worked with."

Who has the better record on handling COVID-19?

Sweden shows the way

While the federal government can suggest to states how they should handle virus outbreaks, controls are primarily the responsibility of States. They can ask for assistance, and the record shows that the Trump administration has done a marvelous job of responding to such requests. But it's still up to the states.

Considering, the facts don't stack up well for the Democrats.

 States totally controlled by Democrats: COVID-19 deaths per thousand - 732

- States with a divided State Government: COVID-19 deaths per thousand – 565
- States totally controlled by Republicans: COVID-19 deaths per thousand – 474

As testing increased, the number of cases increased. That's not a big surprise. Let's ignore the fact that literally hundreds of positive tests have later been proven false.

Let's compare the number of cases reported per day to the number of deaths (which we also know is greatly inflated by attributing deaths to coronavirus when other causes were responsible) reported per day as displayed in these two graphs.

Democrat Gov. JB Pritzker has kept a heavy hand on opening the economy in Illinois based on the number of positive tests. Would a more accurate indicator be the number of deaths?

Note the inconsistency in deaths. The higher numbers are good for headlines. The lower numbers of deaths are ignored by the governor and the media.

Insofar as shutting down the economy, the only means of judging the success or failure of such a measure is consideration of Sweden, which didn't shut down its economy. Sweden's death rate stands at 578 per thousand

while the U.S. rate stands at 598. Which country now has greater immunity to an explosion as we approach winter when people in the northern states again closet themselves for the frigid season or move south?

One country used the 'herd immunity' approach to the pandemic. The other country invoked ridiculous 'Sanitary Mary' laws (no offense to Mary intended). One has herd immunity and the other doesn't. One stayed calm. One was incited to panic by shrill and hourly reports from the mainstream media.

End of an Era in McHenry County Government Recorder Office ceases to exist December 1

No County Recorder campaign signs by the roads? You won't see those anymore. The position is slated for elimination Dec. 1.

When Joe Tirio ran for Recorder in 2016, he promised to eliminate the position, and he kept his promise. He got behind a measure, approved by the County Board, for a binding referendum to eliminate the position. It passed by a 4-1 vote.

Tirio said his goal was to eliminate the cost, nepotism and patronage associated with the position altogether.

In 2018, Tirio ran for Clerk and won. He promplty renounced all pay and benefits as Recorder from that point until the office no longer existed. He handled the duties of both positions at the cost of one. He was doing two jobs for the price of one and two years earlier than promised.

"By December 2020, the Recorder's team will have saved \$1.9 to \$2.1 million dollars as

compared to the budget for 2016," Tirio said. "In other words, the office could run for two years on the savings our team created."

More than financial benefits

When someone requested a document from the Recorder's office, it used to take more than four days before it was available.

"Now, it's often available within minutes," said Tirio. "We're doing that with a staff of 13 rather than the 26 people that did both jobs when I took office.".

Tirio's office also implemented the "Honor Rewards Program" that encourages veterans to register their DD214 with us in exchange for benefits at local businesses and strong Property Fraud Alert subscriptions.

"Today's Recorder's office provides more benefit to the community, at a lower cost, than ever before," said Tirio. "You can thank the remarkable people I work with in the Recorder's office for that."

Running a business for more than 35 years, Richard K. Gelscheit, the owner and operator of Methods Manufacturing of Northern Wisconsin (previously Fox Lake) has witnessed a lot. He's often wondered if it was worth all the effort and worry. Thinking about the alternative, however (working for someone else}, kept him hanging in there no matter

Nobel's intention is clear: to bring leaders of different nations together, reduce regional tensions, enable nations to establish a foothold for regional peace, reduce their armies, and redirect that portion of their national funds spent on war preparedness to helping their own people. Unfortunately, many feel the prize has been subverted by the Nobel Committee to fit a 'Politically Correct' narrative.

If the committee were to strictly adhere to Nobel's Last Will and Testament, we might see years when no peace prize was awarded at all. A strict adherence to Nobel's Last Will and Testament could eliminate dozens of Nobel Laureates at a glance. Sept. 10, Carlos Acosta and Andres Polovin were arrested for negligence in the death of AJ Freund. The 5-year old was killed in 2019 at the hands of his parents. In December, DCFS Inspector General Meryl Paniak recommended that three DCFS employees involved in the case be fired for mishandling the matter.

One of the workers, Kathleen Gold, retired from DCFS last October. We are still waiting to see if she is charged along with Acosta and Polovin.

Immediately after AJ's death, Acosta and his supervisor, Polovin, were placed on desk duty for falsification of records and conducting sham investigations. Acosta is a member of the McHenry County Board.

There were frequent calls for his resignation before his arrests. Many feel that Board Chairman Jack Franks defended Acosta. But, with his arrest, Acosta appears to have stepped beyond the protective reach of his benefactor.

Prim, Kenneally and Skillicorn all deserve praise for their persistent and determined pursuit of justice for AJ. From the time that the story first hit the news, IL Rep. Allen Skillicorn, (R-66th District) worked tirelessly in the pursuit of justice for AJ Freund. Behind the scenes, he petitioned Gov. JB Pritzker to intercede in the case. But Pritzker wasn't interested or simply wouldn't help.

McHenry County Sheriff Bill Prim and McHenry County States Attorney Patrick Kenneally also patiently pushed for justice. They conducted a thorough investigation only acting when they felt they had properly built the case against Acosta and Polovin. All three of these public servants deserve our thanks and appreciation.

Of course, there are still some questions remaining:

- Have Acosta and Polovin been fired from the agency?
- If not, are they still on paid administrative leave?
- If they have been fired, are they collecting Unemployment?
- If convicted, will they collect their county pension?
- Is Kathleen Gold collecting her pension?
- Has Jack Franks finally called for Acosta's resignation from the County Board?

The Case for Term Limits

We've all heard "Power Corrupts, and Absolute Power Corrupts Absolutely". The quote is from 19th Century British politician Lord Acton. And it's still true today. Polls show that 67 to 80 percent of Americans, on a bipartisan basis, support Term Limits at the state or federal level.

There is a significant difference towards Term Limits by the two parties. Chicago's Democrat machine has a long history of corruption. Illinois House Speaker Mike Madigan, the longest-standing speaker of a state house in U.S. history, is under investigation in the ComEd bribery case.

Former VP and Democrat presidential candidate Joe Biden first took federal office in 1973. House Minority Leader Chuck Schumer (D-NY) arrived in 1981, and House Speaker Nancy Pelosi (D-CA) in 1987.

The Founders opposed the concept of career politicians. George Washington pledged to serve no more than two terms and kept his promise. In Federalist No. 1, Alexander Hamilton wrote of "the perverted ambition of men who will hope to aggrandize themselves" and who "will flatter themselves with fairer prospects of elevation..." American politicians have a long history of precisely that.

A group called U.S. Term Limits (www.termlimits.com) proposes limiting members of the House to a maximum of three terms (6 years) and Senators to a maximum of two terms (12 years). This requires a constitutional amendment.

There are two ways to amend the constitution. One is for Congress to pass a proposed amendment, which is then sent to the states for ratification. The other, under Article V, is a Convention of States, where the states meet to prepare a proposed amendment. Any proposed amendment needs to be ratified by three-fourths of the states.

Any proposed amendment needs to be ratified by three-fourths of the states. On the US Term Limits site, some members of Congress have signed the Term Limits pledge: 17 Senators, all Republicans, and 54 House members (52 Republican, 2 Democrat).

Unfortunately, the "congressional route" is effectively blocked by the leadership of the Democrat party. Both the Senate and the House have pending Term Limit legislation. But many Democrats claim elections are the way to limit legislative terms. Rep. Lauren Underwood (D-14) is among them.

On the other hand, many Republicans believe we need a "structural" (constitutional) fix to the problem, similar to ratification of the 22nd Amendment, which limits the president to two terms

The US Term Limits site allows citizens to sign in support of the Term Limits pledge. Candidates can also take the pledge on the site. Jim Oberweis, Republican candidate for the 14th Congressional District, has signed the pledge.

"Career politicians vote in ways they believe will help them get reelected, but term limited politicians vote in ways they believe are in the best interest of our state and our country, then return home," said Oberweis while noting his opponent's objection to the proposal.

to my ears."

"I could not believe it! I was so excited I drove hundreds of miles to hear the future President at five events in three states. Finally, someone really knew, cared about and understood what was happening from the standpoint of the average citizen and, in my case, the small business owner".

Gelscheit said he used the title of President Trumps book NEV-ER GIVE UP as motivation in his own life.

"I'm just about finished reading it and so needed what it offers," he said. "One of the reoccurring themes is having the PATIENCE to take a long-term approach to achieving goals. Another theme is EXPECTING RESISTANCE."

He said that, in his view, President Trump has set an example of taking on so much from the opposition in America while holding the line on China as he does every day.

"A president does not have a lifetime to achieve goals," said Gelscheit. "At best, they have only 8 years. Trump has made so much progress in the first four he's earned the right to another four. Gelscheit worries about the kind of message America will

The Pandemic and Civil Unrest have kicked gun sales into high gear Price of ammo increases as availability suffers

Governor JB Pritzker issued a "Stay at Home," order that took effect March 21, to reduce the spread of the coronavirus. One result related to the COVID-19 pandemic was that many items were in short supply, including toilet paper, hand sanitizer, face masks, some food, firearms and ammunition.

One gun owner leaving Bass Pro Shops in Gurnee, said, "I experienced this shortage in mid-March while attempting to locate 12-gauge ammunition for home defense. After visiting a number of local gun shops in Lake and McHenry counties, I finally found what I was looking for here at Bass Pro Shops, although it wasn't the exact type I was looking for."

Then, at the end of May, George Floyd died at the hands of police in Minneapolis triggering close to four months of civil unrest, so far. Some of the protests were peaceful but, even when that was the case, inevitably, they devolved into, looting, rioting and violent attacks on citizens and law enforcement. Watching all the violence, many Americans felt uneasy; they felt the need to arm themselves. Vastly increased

sales of ammunition caused shortages. And with the shortages came sizeable increases in ammunition prices. Why is ammunition more expensive and in short supply? Simple supply and demand.

In late July, a McHenry County Sheriff, who also serves in the U.S. military, received a welcome home celebration after returning from Af-

ghanistan. Though preferring to not go on the record, the deputy spoke about the effect the unrest is having on recruits joining law enforcement.

The Deputy said there's usually a pool of around 700 applicants to join the Sheriff's department. But, with all the unrest and animosity expressed against the police, when the deputy returned from serving overseas, they found that there was only a pool of 200 candidates for the department.

The nationwide "Defund the Police" movement, along with at-

tacks on law enforcement, has officers resigning and retiring at an alarming rate. As a result, many citizens see the need to take responsibility for their own safety and self-defense.

NICS (National Instant Criminal Background Check System) checks are a strong indicator of firearm purchasing activity. For Illinois, from January through August of 2019, the total number of NICS checks was 2,989,803. For January through August of 2020, the total number of checks is 5,179,673. This is an increase of more than 42 percent over the

same period last year. It's also widely reported in the media that there are more than five-million new, first-time gun owners in the U.S. this year.

As ammunition prices are skyrocketing, the sale of popular firearm calibers, such as the 9mm handgun and .223 rifle, have also exploded.

Prior to the riots, a Marengo Guns email flyer from March 6 listed 9mm ammo at \$15.99 per 100 or 16 cents per round. The price for

.223 ammo was \$13.79 for 50 or 27.6 cents per round with no shortage of supply. But a Sept. 9 flyer shows 9mm ammo running 70-cents per round and .223 at a dollar per round. Self-defense ammo is even higher. In six months, 9mm has increased 337 percent and .223 has increased 262 percent, and some with limited quantities.

The obvious conclusion is that widespread civil unrest and a diminishing police presence will lead to increased purchases of firearms and shortages and price increases of ammunition.


Underwood's exaggerations some might call something else

Most of us are familiar with the photos of Lauren Underwood, our representative in the 14th Congressional District, wearing a nurse's scrubs with a stethoscope hanging around her shoulders. The photo conveys a message that Underwood is a nurse and has the experience to speak empirically about the issue of

healthcare. But it turns out that, while Underwood has a nurse's certificate, she's never actually worked as a nurse.

Some might call the image of her in scrubs something of an exaggeration. Some might say that it's more than that. It conveys a message that isn't exactly true.

the White House, they might even be inclined to dress in attire that fits the location and occasion. Suits and dresses are the order of the day. But that, of course, didn't fit the obvious photo op the Obama administration was seeking.

Accordingly, staffers for the Obama administration had scrubs and stethoscopes on hand for each of the medical professionals that were expected. That way it didn't matter how they dressed for the event; the photogenic props were on hand so that the event could be staged as intended.

"Intended" refers to the purpose of the photo opportunity. The purpose in that case was to

tell Americans that these medical professionals supported the president's legislation. A successful photo conveys its message without requiring explanation.

In other words, the photo falls on its face if people see it, don't make the intended connection, and then fail to follow through and read where it says, 'These are healthcare professionals.'

The problem with Underwood's photo op for her campaign material is that it says 'Experienced Healthcare Professional' where the reality is short on the actual experience. Of course, reading her campaign material also failed to point out her limitations in this regard.

Now, it appears that exaggerating is standard operating procedure for Underwood. For instance, she advertises that she is leading a "Back to School" panel. That may give readers the impression she is pushing for safely opening schools again. Not so fast. She's merely talking about adjusting to further virtual classroom experiences.



McHenry County artist brings creativity to life

Gabe Karagianis explores his passion for his craft

Gabe Karagianis, a professional artist with an art studio in Harvard, has many of his works on the walls of Ethereal Confections, the café on The Woodstock Square owned by his life partner, Mary Ervin, her brother Michael Ervin and Sara Miller.

"I don't see myself as just an

artist," said Karagianis. "I'm a working person, I crepaintings and designs on speculation and commission. Some I sell after the fact. Some are sold before I first take brush to canvas, etc."

He does oils on

canvas but he also does threedimensional art. This includes building things out of wood and custom furniture that you'll often find in his house and studio.

"I think the part of my character that is drawn to art also expresses itself in other ways," he said. "For instance, I enjoy learning new things, solving problems in the physical world.

A couple years ago, he picked up a recurve bow and practiced shooting arrows in his backyard. He loves skateboarding and doing

voga. In the winter he goes out in freezing weather and stands in his shorts to practice breathing exercises.

"I think of myself as a primitive man. But I also appreciate our modern conveniences though I try not to take things for granted.

"I remember to humble myself before my Creator and give thanks for the life I've lived so

far. I ask for the courage and strenath to endure what is to come.

Midwest-Α erner, he consid-Woodstock the countryside. Big cities tend to get all the press, he says, and people in them tend to be-

lieve that country-folk are illiterate or unambitious. Making art in a 'fly-over' state certainly isn't economically advantageous, but Gabe doesn't usually make decisions based on material reward or fame.

"There isn't a cohesive 'art scene' in the area," he said. "The talented artists here are generally loners who are happy living a low-key, simple life.

"Don't get me wrong, I do enjoy taking trips to see family and explore new places – going to art museums and restaurants - but there's nothing like returning to my favorite cafe or getting back to work in my studio in Harvard."

His studio is in the Starline Building, an old factory built in 1883. describes it as like work-

ing in a castle and believes it has always had a subtle influence on his work.

In that regard, he tries to maintain an awareness of the past - to stretch his imagination back centuries and millennia of the ancient world.

"I live in a world of symbols which aren't confined to linguistic or even cultural restraints. The symbols I draw on for inspiration are universal and archetypal, and the work that I produce is an effort to add to that universal and timeless visual tapestry.

"We think of ourselves as separate from those who forged the way and sacrificed their beliefs and traditions laving the groundwork for the world we know today. Unfortunately, many today seem to reject their spiritual exis-

He said he thinks we've exchanged 'superstition' for the superficial.

"I think that we need meaning in our lives and, for me, it's important to integrate my existence with everything that came before me."

Aside from all that, he said it's just such a pleasure to spend time dreaming up colors and shapes and molding them into something that feels complete and real.

"Finishing a piece from inception to sketch to finished product is incredibly satisfying, I'm grateful for every opportunity.
